Ticketing Terms and Conditions

GENERAL

- a) These Terms and conditions (T&Cs) incorporate, and should be read together with, any Vendor's and/or Agent's T&Cs or regulations, which you can obtain from the point of purchase from the Official Agent
- b) Artists and billed attractions may be subject to change
- c) From time to time Margate Soul Festival Ltd (MSF) may offer discounted rates of the original face value of the ticket each year. This may be in the form of earlybird, flash or local sales.
- d) Goods using unauthorised event logos and unauthorised professional recording equipment must be surrendered to staff.
- e) Do not buy tickets or goods from unlawful street traders/touts. They are invalid.
- f) You give your express consent to your actual/simulated likeness to be included for no fee within any audio or visual recording to be used in any media for any purpose at any time. This includes filming by the police or security staff which may be carried out for the security of customers and/or the prevention of crime.
- g) No unauthorised buses, coaches or trucks will be allowed on site.

REFUNDS

 a) Refunds are only considered on major cancellation, substantial programme alteration or by special exception determined by MSF

- b) Refunds should be obtained from the point of purchase, no later than 3 months after the event.
- c) A minimum of the face value of the ticket will be refunded.
- d) No refunds will be made for any failure to perform, or delay in performance of any of obligations under these Terms that is caused by an Event Outside The Control of MSF which means any act or event beyond the reasonable control of MSF, including without limitation strikes, lock-outs or other industrial action by third parties, non-performance by the Promoter, the suppliers or other third parties, civil commotion, riot, invasion, terrorist attack or threat of terrorist attack, war (whether declared or not) or threat or preparation for war, fire, explosion, storm, flood, earthquake, subsidence, epidemic, pandemic or other natural disaster, or failure of public or private telecommunications networks or impossibility of the use of railways, shipping, aircraft, motor transport or other means of public or private transport.
- e) Refunds of booking fees per ticket are subject to the T&Cs of the point of sale.

AGE POLICY

- a) No unaccompanied under 17's are allowed on site.
- b) Under 17's must be accompanied by an over 18s.
- c) Children between 7 17 years old need a child's ticket to enter ticketed parts of the festival.
- Ticketed venues for under 18s access are Newgate Lower Promenade (Main Festival Site 2pm - 10pm

TICKETS AND WRISTBANDS

• a) Tickets are non-transferable and only valid when purchased from official agents of MSF.

- b) All tickets advertised are the advance prices up 2pm on each day of the festival. Purchases made on the day will be subject to an increase plus booking fees.
- c) Tickets/wristbands purchased from unauthorised sources will be rendered invalid and refused admission.
- d) Tickets must be exchanged for a wristband on first entry at a wristband exchange.
- e) Tickets must be valid, presented in full, with stubs and not tampered with (in the event of accidental damage, refer to point of purchase prior to event).
- f) Tickets remain the property of Margate Soul Festival.
- g) MSF will not issue duplicates for lost or stolen tickets or wristbands.
- h) Tickets cannot be used as part of any marketing, media or sales promotion, without the prior written consent of MSF.
- i) The ticket holder is responsible for their tickets until it is exchanged for a wristband and then responsible for their wristband for the duration of the event.
- j) All wristbands remain the property of MSF until 12 Noon the day after the last day of the event.

COMPANION TICKETS

 a) Companion tickets are available exclusively for individuals with disabilities who require assistance to attend the Margate Soul Festival. Proof of eligibility may be requested at the time of application, such as a valid Blue Badge, Access Card, or similar documentation. The festival organisers reserve the right to verify eligibility to ensure appropriate allocation of Companion tickets.

- b) To apply for a Companion ticket, eligible individuals must complete and submit the application form available on request by emailing access@margatesoulfestival.co.uk. Applications must be received no later than 30 days prior to the event. Late submissions will not be considered, and it is the responsibility of the applicant to ensure timely submission.
- c) Companion tickets are issued on a strictly non-transferable basis. The designated companion must accompany the eligible ticket holder throughout the duration of the festival. Any attempt to sell, exchange, or transfer the Companion ticket will result in the cancellation of both the Companion and the primary ticket without a refund.
- d) Companion tickets grant access to the same areas as the primary ticket holder and must be used in conjunction with a valid primary ticket. Both the eligible individual and their companion must adhere to all festival rules and regulations. Any breach of these terms and conditions may result in ejection from the festival premises and forfeiture of the ticket(s) without a refund.

SECURITY

- a) MSF reserves the right to evict a customer without refund, and/or refuse admission. See Eviction Policy *
- b) You may be body/bag searched at the entrances, on the site or when leaving.
- c) Any item(s), reasonably considered for use as a weapon, which may cause danger, offence or disruption to any other person, must be surrendered to staff**.
- d) Any person carrying illegal items or carrying out illegal activity will be given to the Police and refused entry. Please see confiscation/surrender policy**.
- e) Anti-social behaviour may lead to eviction*. Please act responsibly.
- f) Throwing gas, aerosol or similar canisters/containers onto fires is extremely dangerous and will lead to eviction*.

DAMAGE/LOSSES

MSF is unable to accept any liability for personal or property damages, losses (including surrendered items) or injuries sustained at this event – other than caused as a result of our negligence.

BANNED ITEMS

- a) Banned from event Gas canisters, aerosols over 250ml, airhorns, fireworks, flares, glass, illegal substances, drugs, 'legal highs' this includes Nitrous Oxide,
- laser equipment/pens, megaphones, nitrous oxide, sky or 'Chinese' lanterns, sound systems, spray cans, tabards/high visual jackets.
- b) Banned from ticketed area of event Cans, disposable BBQs, campsite stoves, umbrellas, large and open bottles of water (500ml are permitted).
- c) Generators except those provided by the MSF e-scooters, segways or hoverboards.
- d) Food, excessive cigarettes no alcohol from outside authorised vendors.
- e) Anyone resisting the surrender of disallowed items or disregarding these conditions will face eviction*.
- f) Under 18's are not permitted to purchase alcohol on site.
- g) It is illegal for an over 18 to purchase alcohol on the behalf of under 18s.

FIRE AND SAFETY

- a) Fires are not permitted in the ticketed areas of the festival.
- b) The burning of plastics, bedding, tents, furniture etc is not permitted anywhere on site.

- c) Smoking is not permitted in enclosed public spaces or buildings. This includes e cigs.
- d) Excessive exposure to loud music may cause damage to your hearing.
- e) Pyrotechnics, lasers, smoke machines, strobe lighting/special effects may take place during some performances.
- f) The use of Drones or similar equipment for any reason is prohibited on or near the event.

HOUSEKEEPING

- a) Please use the bins and recycling points provided on and off site.
- b) No animals, other than guide or hearing dogs, are permitted on site.
